

## Taos County Association of REALTORS® (TCAR) MLS Tour Zones Map

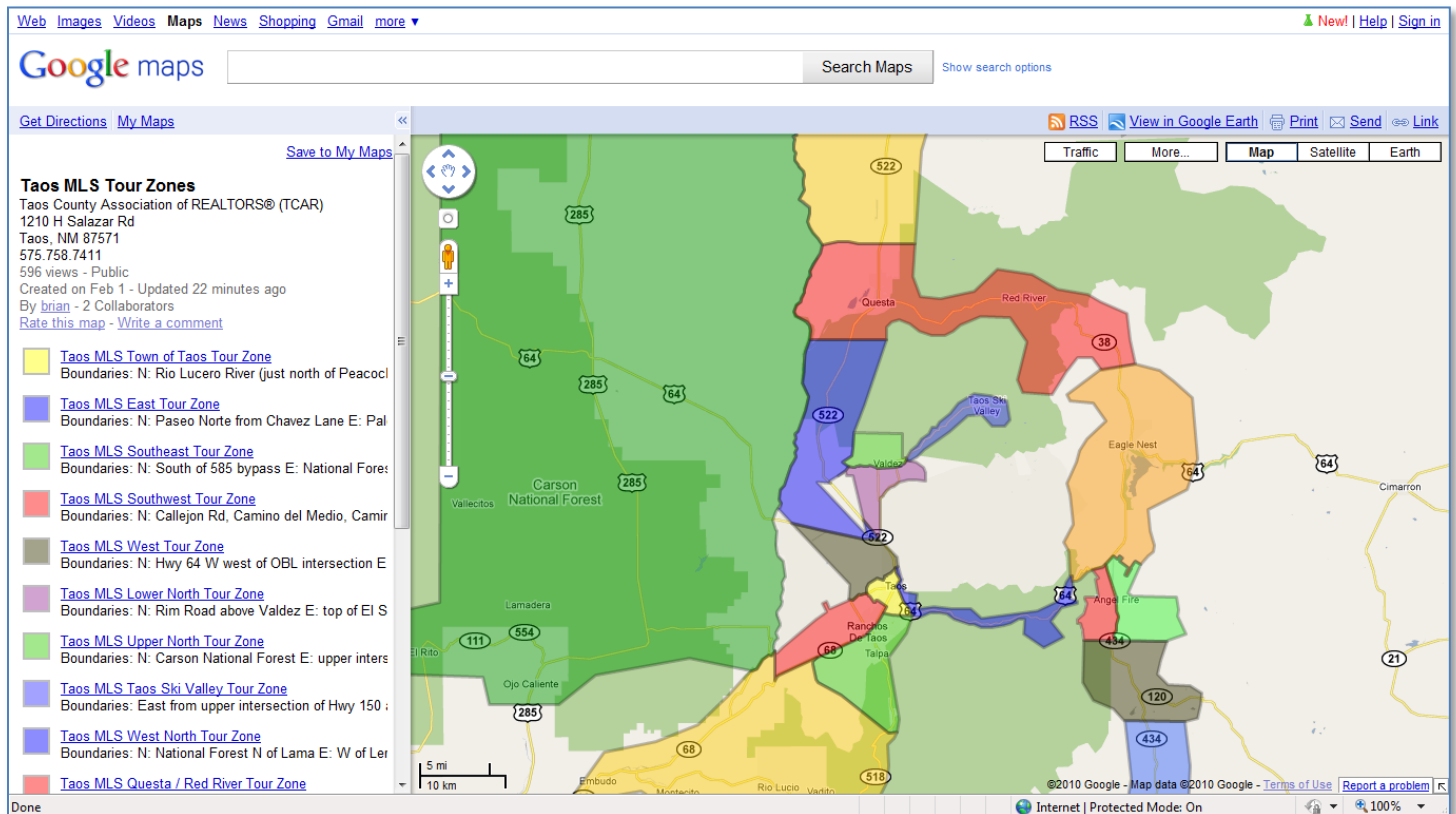
The Tour Zones Map for the Taos County Association of REALTORS® (TCAR) has been developed and is located on Google maps. The map is interactive, and provides the user with the ability to view in normal map mode, as well as any other feature offered by Google maps. The user may zoom in for a micro view or zoom out for a broad view. The user may also use the street level view on main streets or highways where Google has made street views available.

You may use all the features of a Google map, including zooming in, zooming out, panning in any direction, switching to the Satellite view, the Terrain view, the Traffic view, or the Street Level view, if Google has developed these features for the area of the map you are viewing.

### Town of Taos Tour Zone:

**Boundaries:**

**N:** Rio Lucero River (just north of Peacock Ln); Paseo Norte from Chavez Lane  
**E:** Hwy 64 at 585 bypass  
**S:** 585 bypass, Paseo del Pueblo Sur, Camino de la Merced, Camino del Medio, and Callejon Rd  
**W:** Northern boundaries of properties accessed from NM 240 between Upper Ranchitos Rd and Callejon Rd; Western boundaries of properties accessed from Upper Ranchitos Rd

### East Tour Zone:

**Boundaries:**

**N:** Carson National Forest  
**E:** Palo Flechado Pass  
**S:** Carson National Forest  
**W:** Hwy 64 at 585 bypass

### Southeast Tour Zone:

**Boundaries:**

**N:** South of 585 bypass  
**E:** National Forest bypass  
**S:** Stakeout and North of Stakeout  
**W:** Hwy 68

### Southwest Tour Zone:

**Boundaries:**

**N:** Callejon Rd, Camino del Medio, Camino de la Merced  
**E:** Hwy 68  
**S:** Hwy 68 Horseshoe Curve  
**W:** Line from Hwy 68 Horseshoe Curve to Taos Pueblo Tract A; Taos Pueblo Tract A;  
Northern boundaries of properties accessed from NM 240 between Los Cordovas Rd and Callejon Rd; Southern boundaries of properties accessed from Blueberry Hill Rd and Cottom Rd

### West Tour Zone:

**Boundaries:**

**N:** Hwy 64 W west of OBL intersection  
**E:** Taos Pueblo land east of OBL intersection, Chavez Ln, Hwy 64  
**S:** Rio Lucero River (just north of Peacock Ln); Western boundaries of properties accessed from Upper Ranchitos Rd; Northern boundaries of properties accessed from NM 240 between Upper Ranchitos Rd and Los Cordovas Rd; Southern boundaries of properties accessed from Blueberry Hill Rd and Cottom Rd  
**W:** Taos Pueblo Tract A

### Lower North Tour Zone:

**Boundaries:**

**N:** Rim Road above Valdez  
**E:** top of El Salto Rd (Water Assn)  
**S:** Hwy 150 and El Salto Rd  
**W:** on and E of Leroux Rd (Sunset Hills Rd)

### Upper North Tour Zone:

**Boundaries:**

**N:** Carson National Forest  
**E:** upper intersection of Hwy 150 & 230  
**S:** Rim Road above Valdez  
**W:** National Forest

### Taos Ski Valley Tour Zone:

**Boundaries:**

East from upper intersection of Hwy 150 and Hwy 230 thru Amizette up to Taos Ski Valley

### West North Tour Zone:

**Boundaries:**

**N:** National Forest N of Lama  
**E:** W of Leroux Rd (Sunset Hills Rd)  
**S:** Hwy 64/522/150 Junction  
**W:** Rio Grande River

### Questa / Red River Tour Zone:

**Boundaries:**

**N:** Port of Entry  
**E:** Red River  
**S:** Forest Road N of Lama  
**W:** Rio Grande River

### Far North Tour Zone:

**Boundaries:**

**N:** New Mexico / Colorado border  
**E:** Amalia / Rio Costilla Ski Area  
**S:** Port of Entry  
**W:** Rio Grande River

### Far South Tour Zone:

**Boundaries:**

**N:** Hwy 518 east of Pot Creek, Hwy 68 south of Horseshoe Curve  
**E:** Tres Ritos/Sipapu  
**S:** Velarde  
**W:** slightly across Rio Grande River

### Far Southeast Tour Zone:

**Boundaries:**

Generally Mora and surrounding areas

### Far West Tour Zone:

**Boundaries:**

**N:** New Mexico / Colorado Border  
**E:** Rio Grande River  
**S:** Ojo Caliente  
**W:** Chama Pass on Hwy 64

### Angel Fire North Tour Zone:

**Boundaries:**

North of Angel Fire Resort including Taos Pines Ranch and everything to Eagle Nest

### Angel Fire East Tour Zone:

**Boundaries:**

Within Angel Fire Resort & East of Hwy 434

### Angel Fire South Tour Zone:

**Boundaries:**

South of Angel Fire Resort including Black Lake area to Hidden Lake

### Angel Fire West Tour Zone:

**Boundaries:**

Within Angel Fire Resort & West of Hwy 434
